AN ORDINANCE TO APPOINT MEMBERS TO THE NEWLY REINSTITUTED INDUSTRIAL DEVELOPMENT BOARD OF THE CITY OF EAST RIDGE AND AUTHORIZE THE INDUSTRIAL DEVELOPMENT BOARD TO SERVE IN AN ADVISORY CAPACITY THEREBY REPLACING THE FORMER ECONOMIC ADVISORY BOARD

RESOLUTION 2397

- WHEREAS,** the City of East Ridge has an Economic Advisory Board that provides the East Ridge City Council with advisory opinions on commercial and residential development and the City's economic and community development programs within the municipality; and,
- WHEREAS,** the East Ridge Economic Advisory Board is a separate body from the Industrial Development Board; and,
- WHEREAS** the City of East Ridge wishes to create a more efficient and effective economic development planning process by reducing the number of advisory and statutory boards and associated meetings while maintaining the highest quality input from East Ridge citizens regarding economic and community development; and,
- WHEREAS,** the City of East Ridge desires to eliminate the Economic Advisory Board and combine the functions of the Industrial Development Board and Economic Advisory Board; and,
- WHEREAS,** *Tennessee Code Annotated* § 7-53-101 et seq. authorizes a municipal governing body to designate members to the Industrial Development Board serving staggered terms of office.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF EAST RIDGE TENNESSEE THAT:

- Section 1. The City of East Ridge City Council is hereby appoints the following East Ridge citizens to serve on the Industrial Development Board of the City of East Ridge for the terms as stated in Exhibit "A" attached hereto.
- Section 2. The provisions of this ^{Resolution} ~~Ordinance~~ are severable. If any provision of this ^{Resolution} ~~Ordinance~~ or the application thereof to any person or circumstance is held to be invalid by a court of competent jurisdiction, such invalidity shall not affect other provisions or applications of this ^{Resolution} ~~Ordinance~~ that can be given effect without the invalid provision or application.
- Section 3. This ^{Resolution} ~~Ordinance~~ shall take effect immediately after its final passage, the public welfare requiring it.




