The City of East Ridge hereby issues public notice in accordance with Governor Bill Lee's signed Executive Order No. 16 ("Order No. 16") and extended by Executive Order No. 34 ("Order No. 34") and Executive Order No. 51 ("Order No. 51") of a Planning Commission meeting that will be conducted permitting participation of the Commission members by electronic or other means of communication beginning on the date and time and at the physical location established hereinabove.
