AGENDA MEMORANDUM CAMP JORDAN PARK Victus Advisors Study

SUBJECT:

Victus Advisors completed and presented a sports facility feasibility study mid-year 2024 for Camp Jordan Park; specifically, to explore the financial feasibility of enhancing, improving and optimizing the outdoor and indoor sports complex to more effectively serve our local residents while maximizing our opportunities to capitalize on sports tourism via regional tournaments and national events.

Based on the input from the City, Victus recommended the following two models:

- An upgraded outdoor complex that would consist of converting six (6) soccer fields and six (6) ball fields to artificial turf; and
- The construction of a new indoor sports center that would feature 10 hardwood basketball courts that could be converted to 16 to 20 volleyball courts, as well as capabilities for other sports uses as volleyball, pickleball, wrestling, cheer, etc.

From the final report, Victus' summary of net economic and fiscal impacts over a 30-year period provided an estimate that the proposed new and improved sports tourism facilities could generate a monumental long-term economic and fiscal impacts.

Mayor Brian Williams and City Staff (Shawnna Skiles, Chad Ayers and City Manager) met with Mayor Wamp and his Management Staff in mid-September 2024 to talk about the proposed improvements/enhancements that were recommended in the Victus Advisors Study; specifically, the turfing of fields (soccer and baseball) and the construction of an indoor sports arena (basketball, volleyball, etc.).

Part of the discussions involved the financial participation of Hamilton County with the City of East Ridge in this venture. It appears that Hamilton County could match the dollars the City appropriates for the turfing of fields. The City has the opportunity to obtain matching funds for this project; therefore, I am asking for the Council's direction and consideration to turf a portion of baseball and soccer fields in Camp Jordan should Hamilton County agree to participate financially with the City of East Ridge.

SPORTS FACILITY USAGE PROJECTIONS



Overview - Based on input from the City, we created the following two (2) models for analysis:

Upgraded Outdoor Complex

Features: Conversion of six (6) rectangular fields and six (6) ball diamonds to artificial turf. It is recommended that all of the artificial turf fields should have lights.

New Indoor Sports Center (approximately 150,000 sq. ft.)

Features: 10 hardwood basketball courts, convertible to 16 to 20 volleyball courts, as well as capabilities for other sports uses such as pickleball, wrestling, cheer, etc.

Outdoor Sports Complex Incremental Annual Utilization - As shown at below, we are estimating at least 15 incremental sports tournaments/events per year with an upgraded outdoor complex. It should be noted that the incremental events would be a mix of 1-day and 2-days events:

Return on Investment Analysis - As shown below, based on an analysis of estimated total capitalized project costs (construction, operations, and maintenance reserves) versus incremental annual direct spending generated from new visitors, both the upgraded outdoor fields and indoor sports center are expected to have a positive return on investment (ROI).

When measured against net new direct spending attracted to the area via new sports tourism visitors:

- Outdoor field upgrades are expected to have an internal rate of return (IRR) of 37% and a payback period of 3.5 years
- A new indoor sports center is estimated to have an IRR of 28% and a payback period of 5.2 years.

RESOLUTION NO. 3628

A RESOLUTION OF THE EAST RIDGE CITY COUNCIL AUTHORIZING THE MAYOR TO ENTER INTO AN JOINT PROJECT AGREEMENT BETWEEN THE CITY OF EAST RIDGE AND HAMILTON COUNTY TO TURF CERTAIN ATHLETIC FIELDS AT CAMP JORDAN PARK

WHEREAS, Victus Advisors completed a sports facility feasibility study mid-year 2024 for Camp Jordan; specifically, to explore the financial feasibility of enhancing, improving and optimizing the outdoor and indoor sports facilities.

WHEREAS, one of the findings of this study based on the input of the City and interviews with existing event users confirmed that the City would be able to add multiple events at Camp Jordan if several of the existing soccer and ball fields were converted to artificial turf to host play and events, especially in the event of inclement weather; and

WHEREAS, the Mayors of the City of East Ridge and Hamilton County met to discuss the merits of the Victus study and the County's financial participation in the conversion of soccer and ball fields to turf, and it appeared that the Mayor of Hamilton County could match the appropriation of the City for the turfing of the fields.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of East Ridge, Tennessee that the Mayor be authorized to enter into a joint project agreement with Hamilton County, where the City would spend \$3 million for artificial turf on athletic fields at Camp Jordan Park, and the County would match the amount of \$3 million.

BE IT FURTHER RESOLVED that the City's match of \$3 million would come from the Fund Balance of the General Fund.

BE IT FURTHER AND FINALLY RESOLVED that this resolution shall take effect immediately after its passage, the public welfare of the City requiring it
