**PROJECT DESCRIPTION**

This project involves the resurfacing of John Ross Road from SR-8/US-41 (Ringgold Road) to Sunrise Terrace in East Ridge. The scope of work includes: traffic control, cold planing existing pavement, resurfacing pavement, replacement of traffic signal loop detectors, pavement markings, signage, and multimodal upgrades including new ADA curb ramps, pushbuttons, and pushbutton posts. The total project length is 1.30 miles.
