Monthly Report – March 2024

Grant Project Updates:

• TDOT PIN 120226 (McBrien Road Resurfacing)

Thompson Engineering and Talley Construction began construction on 3/11/2024, in the 1400 block of McBrien Road. Work was expected to be completed within (14) days; however, due to a few minor punch list items, the project was completed in (20) days. A contract extension request was submitted to TDOT Local Programs on 2/28/2024 for a 60-day extension —pending approval. A final inspection for PIN 120226 will be scheduled within the next week and completed by Thompson Engineering.

• TDOT PIN 131488 (John Ross Road Resurfacing)

City Administration and Volkert Engineering submitted final ROW plans on 3/5/2024. City Administration received the Notice to Proceed for the Right-of-Way phase on the subject project on 3/8/2024. Volkert Engineering submitted construction plans for review on 3/27/2024. Construction plans are pending approval from TDOT Local Program's Office.

• TDOT PIN 122000 (Multimodal)

City Administration received fully executed amendment 8 extending the project completion date to June 30, 2024. TDOT Local Programs and the City's ECD department worked together to submit final invoices to the State for reimbursement. City Administration received fully executed Change Order #4 on 3/15/2024. CO #4 encompasses equipment and materials not originally covered by the project's scope of work. Since then, CO #4 has been approved by TDOT Local Program's Office.

Violent Crime Intervention Fund Grant

City Administration and Assistant Chief Creel balanced the VCIF budget for FY24 by reimbursing all expenditures covered by the project's original scope of work. In addition, all items covered under the budget amendment approved by the Office of Criminal Justice Programs were purchased and processed by the City's Finance Department.

Statewide School Resource Officer Endowment Grant

Chief Uselton is working with City administration to purchase equipment for the new School Resource Officers. City Administration is working to place recently hired personnel into local schools to serve as SROs.

Local Parks & Recreation Fund Grant

City administration and Parks & Recreation staff submitted the Protected Boundary Map for review on 3/20/2024. The PBM was approved by TDEC's RRD on 3/27/2024 with instructions on how to properly register the Protected Area with Hamilton County's Register of Deeds Office. Staff have been working to complete this task by officially submitting the Land Protection Packet for approval. An RFQ has been advertised for Grant Administration and Design Services for the subject project. Statement of Qualifications from submitting firms are due no later than 2:30pm EST on 4/17/2024.

Chief's Monthly Report

March 2024

The Police Department responded to a total of 2342 calls for service during March 2024.

The department filled a total of 22 open records requests from citizens and the DA's office.

A total of 994 traffic stops were conducted and 963 citations were issued.

ERPD made a total of 90 physical arrests that included 136 misdemeanor charges and 44 felony charges.

The department currently has 1 probationary officer in the Field Training Program, and 4 probationary officers attending the police academy.

ERPD answered 8 calls within the City of Ridgeside and conducted daily self-initiated (directed patrols, park and walks etc.) activities.

K9 NOTE: CSU Investigator and Corporal Beadle have completed a course of instruction this past month which was hosted by the Tennessee Dangerous Drug Task Force. Beadle, and K9 Quest, continue to proactive efforts to mitigate the influx of drugs into the community. The K9 Team has worked closely with the Crime Suppression Unit to build cases and develop additional intelligence. The K9 team has worked closely with other Agencies to include the Hamilton County Sheriff's Office in combatting the influx of drugs into our community. A properly outfitted K9 vehicle has been placed into active service this month. This acquisition is expected to have an increase in productivity of the K9 unit.

Fire Operations

The Department responded to 279 calls for service in the month of March 2024.

Fire Administration

- Staff has scheduled fire inspections and training for each shift.
- Staff has scheduled cancer testing for all employees.
- Staff has submitted the department budget needs to Finance, Human Resources, and the City Manager.
- The Chief and Deputy Chief attended a budget meeting with the City Manager and the Finance Director. In this meeting we went over budget needs and to look at adjusting for future needs.
- Staff is continuing to work with vendors that have upcoming events in the park. Some
 of these are the Taco Festival, the Bacon Festival, the Apple Festival, and ANF (All or
 Nothing fights). Fire department will have crews establish a unified command post for
 the larger events to handle any incidents such as monitoring weather, medical needs,
 security needs, and any other potential hazards.
- Staff included training for in-service in this month's training schedule.

Training

Each shift completes a minimum of two hours of training each shift normally. Training topics for March were:

- Fire Service: SCBA Evolution, Fielder's Choice, air consumption drill. (2/hour minimum).
- In-Service: EVOC, Low angle rescue, swift water rescue (8/hour minimum).

- In Service: RIT/Firefighter Survival, VEIS (8/hour minimum).

- Driver Training: District review-streets, hydrants/FDC, and pre-plans/Inspection. (2/hour minimum).
- In Service: Incident Command, Triage, Hazmat Operations. (8/hour minimum).
- Fire Service: Building Materials, Structural Collapse and the effects of Fire Suppression, Essentials 7 Ch. 16 (2/hours minimum).
- In Service: CPR Refresher (4/hour minimum).
- EMS: First Responder Protocol Manual, PROT-017 to PROT-024. (3 hour/minimum).
- Fire Service: Technical Rescue Support and Vehicle Extrication Operations, Essentials 7 Ch. 17 (2 hour)

We currently have two members in a First Responder Class at Highway 58 Fire Department and two members in the Hamilton County Firefighter II class.
